- When filing a claim, have your policy number handy and a phone number where you can be reached.
- For a property claim, call Tower Hill Claims at (800) 216-3711.
- For a flood claim under Tower Hill Preferred Insurance Company or Omega Insurance Company, contact National Flood Service at (800) 759-8656. If your policy is through Tower Hill Prime Insurance Company, call Torrent Flood at (877) 254-6819.
- Be sure to separate damaged and undamaged items, keeping a list of the damaged items and their value.
